THE FALL 2016 FTE (IPED DEFINITION) ENROLLMENT SHOWS A TOTAL OF 817 UNDERGRADUATE STUDENTS INCLUDING DUAL ENROLLMENT HIGH SCHOOL STUDENTS, 1094 GRADUATE STUDENTS, AND 601 LAW STUDENTS. TUITION FOR ACADEMIC YEAR 2016-2017 WAS \$29,550 FOR FULL TIME UNDERGRADUATE STUDENTS AND \$40,282 FOR FULL TIME LAW STUDENTS. GRADUATE TUITION RANGED BETWEEN \$537 AND \$912 PER CREDIT.
